**WHEREAS**, Assignee desires to acquire from Assignor all of Assignor's right, title and interest in and to the Trademarks and the Registrations together with that part of the goodwill of the business in connection with which the Trademarks are used and which is symbolized by the Trademarks, along with the right to sue and recover damages and profits for past infringements thereof.


