
ASSIGNMENT OF TRADEMARK

WHEREAS, E.I DUPONT DE NEMOURS AND COMPANY, a company incorporated under the laws of the State of Delaware, United States of America, having its principal office at 1007 Market Street, Wilmington, Delaware, ("DUPONT"), desires to acquire all of ATOFINA's rights, title and interest in and to the Trademarks listed on Schedule "A" of this Assignment and the goodwill symbolized by said.


NOW THEREFORE, for consideration set forth and other good and valuable consideration paid to ATOFINA, the receipt and sufficiency of which is hereby acknowledged, ATOFINA does hereby sell, assign and transfer unto DUPONT, its successors and assigns, all of ATOFINA's right, title and interest in and to said Trademarks, and the goodwill symbolized by said Trademark, the same to be held and enjoyed by DUPONT, its successors and assigns; and ATOFINA hereby authorizes and requests the Commissioner of Patents and Trademark of Trademark Office in which the listed Trademark was filed for registration as set forth in Schedule A attached hereto, to record the Assignment to said Trademark and the goodwill symbolized by said Trademark to DUPONT, its successors and assigns, in accordance with the terms of this Assignment.

This Agreement is entered into with effective date as of the 3rd day of September, 2002 by and between Atofina, S.A. and and E.I. du Pont de Nemours and Company, in Paris.
