NOTICE OF RELINQUISHMENT OF SECURITY INTERESTS

WHEREAS, Core-Mark International, Inc. Pursuant to the provisions of Nevada Revised Statutes,
Article 7, Chapter 78, the undersigned officers of Core-Mark
Distributors, Inc., a Nevada corporation (the "Corporation") do
hereby certify:

FIRST: As of April 9, 1990, by unanimous written
consent of the Board of Directors, the Corporation duly adopted
the following resolutions authorizing the following Amendments to
Articles of Incorporation:

WHEREAS, on December 29, 1985, CHI
Holding Corp., a corporation then organized
and existing under the laws of the State of
Delaware, was merged with and into the
Corporation, with the Corporation as the
surviving corporation; and a Certificate of
Ownership and Merger (the "Certificate of
Merger") with respect thereto was filed by
CHI Holding Corp. with the Secretary of State
of the State of Nevada and the Secretary of
State of the State of Delaware;

WHEREAS, Article FIFTH of the Certificate
of Merger incorrectly sets forth the intended
authorized capital stock of the corporation to
be in effect following the Merger; and

WHEREAS, the Corporation desires to
change its name to "Core-Mark International,
Inc.":

RESOLVED, that the Certificate of
Incorporation of the Corporation be amended as
follows:

(x) by striking Article I thereof in its
entirety and substituting in lieu thereof
the following:

* * *

"I. Name:

That the name of the Corporation
shall be Core-Mark International, Inc."

(y) by striking Article IV thereof in its entirety and substituting in lieu thereof:

***IV. Authorization of Capital Stock:**

(1) The total number of shares of all classes of stock which the corporation shall be authorized to issue is twenty-one million (21,000,000) shares, consisting of

(i) twenty million (20,000,000) shares of Common Stock, par value \$0.01 per share, and

(ii) one million (1,000,000) shares of Preferred Stock, par value \$0.01 per share.

(2) The Preferred Stock may be issued from time to time in classes or series and shall have such designations, preferences and relative, participating, optional or other special rights, and qualification, limitations or restrictions thereof, as shall be stated and expressed in the resolutions of the Board of Directors providing for the issuance of such stock, pursuant to the authority hereby vested in the Board of Directors.*

RESOLVED FURTHER, that the officers of the Corporation be, and they hereby are, authorized to take such actions and to execute, file and deliver such documents, agreements and instruments, as shall be necessary or desirable to certify, evidence or effect the foregoing resolutions.

SECOND: The sole stockholder has dispensed with the holding of a meeting of stockholders and adopted the amendments
