Now, therefore, for good and valuable consideration, namely, the payment of Twenty Thousand Dollars (\$20,000.00), the receipt of which is hereby acknowledged, Assignor hereby assigns to Assignee, and its successors in interest, all right, title and interest it may have in and to said marks, together with the goodwill of the business symbolized by said marks and applications thereof, and including all common-law and other rights in said marks, all claims, demands and causes for action, both at law and in equity, that Assignor may have, or may hereinafter acquire, on account of any infringement of said marks prior to the date hereof, and

does hereby empower Assignee, and its successors in interest, to sue for and collect the same, to its and their own and absolute use.

Notwithstanding the foregoing, Inductis Group LLC shall have sixty (60) days to discontinue all use of the mark "DECIDERIGHT" or any mark containing "DECIDERIGHT" or anything confusing thereto. During that sixty-day period, Inductis Group LLC will do nothing to impugn the goodwill associated with the "DECIDERIGHT" marks and agrees that any products it offers in connection with the "DECIDERIGHT" marks during this sixty-day period will be at least the same quality as the products it previously offered in connection with these marks. After the expiration of the sixty-day period, Inductis Group LLC agrees that it shall not in the future use "DECIDERIGHT" or any mark containing "DECIDERIGHT" or any mark confusingly similar thereto.
