THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of November 11, 2004, by UPS Capital Global Trade Finance Corporation ("**Lender**").

WITNESSETH:

WHEREAS, Lender and Tag-It Pacific, Inc. 
WHEREAS, Company has requested that Lender release its lien on the Trademarks and the other collateral described in the Security Agreement and reassign the same to Company;
