**GRANT OF SECURITY INTEREST
IN UNITED STATES PATENTS AND TRADEMARKS**

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Outokumpu Heatcraft USA LLC, a Delaware limited liability company, Outokumpu American Brass, Inc., a Delaware corporation, Outokumpu Copper Franklin, Inc., a Delaware corporation (together, the "Grantors") with principal offices as set out in Schedule 1 hereof, hereby grants to Nordea Bank Finland Plc, as Security Agent, with principal offices as set out in Schedule 1, (the "Grantee"), a security interest in (i) all of each Grantor's right, title and interest in and to the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule 2 attached hereto, (ii) all of each Grantor's right, title and interest in and to the United States patents (the "Patents") set forth in schedule 3 attached hereto, (iii) all Proceeds (as such term is defined in the Security Agreement referred to below) and products of the Marks and the Patents, (iv) the goodwill of the businesses with which the Marks and Patents are associated and (v) all causes of action arising prior to or after the date hereof for infringement of any of the Marks and the Patents or unfair competition regarding the same.

THIS GRANT is made to secure the satisfactory performance and payment of all the Secured Obligations of each Grantor, as such term is defined in the Security Agreement among the Grantors, the other assignors from time to time party thereto and the Grantee, dated as of June 7, 2005 (as amended, modified, restated and/or supplemented from time to time, the "Security Agreement"). Upon the termination of the Security Period (as defined in the Security Agreement), the Grantee shall execute, acknowledge, and deliver to the Grantor an instrument in writing releasing the security interest in the Marks and Patents acquired under this Grant.

This Grant has been granted in conjunction with the security interest granted to the Grantee under the Security Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.
