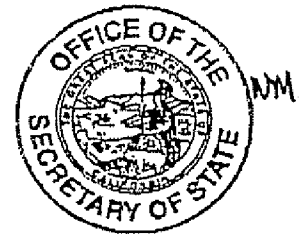
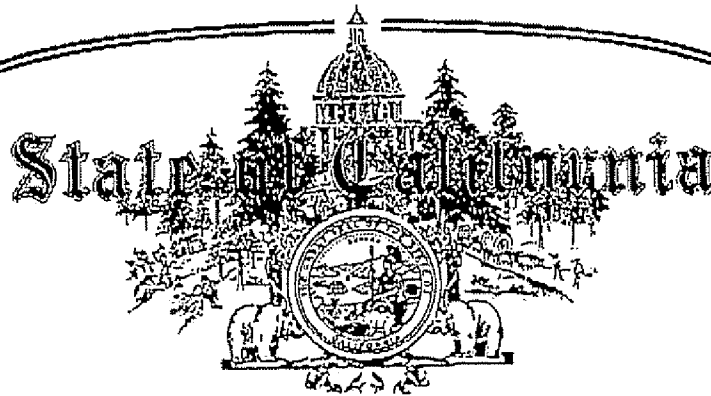

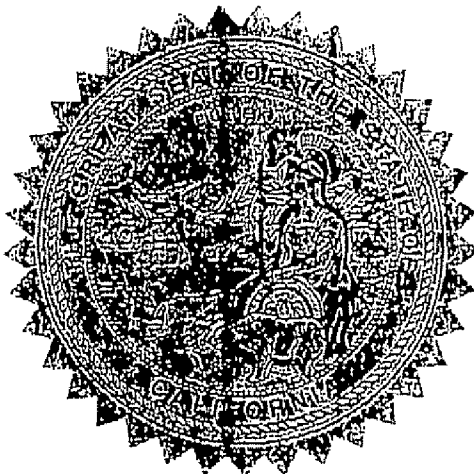

2. Article I of the articles of incorporation of this corporation is amended to read as follows:


"The name of this corporation is BOWTIE, INC."
