FORM OF  
TRADEMARK COLLATERAL AGREEMENT AND NOTICE

This Trademark Collateral Agreement and Notice dated as of June 8, 2005, is among Converge, Inc., a Delaware corporation with its principal place of business at 4497 Park Drive, Norcross, Georgia 30093, and 6D Converge, Inc, a Delaware corporation with its principal place of business at 4497 Park Drive, Norcross, Georgia 30093 (collectively "Borrower"), Converge, Inc. and 6D Converge, Inc., as cross-corporate guarantors ("Guarantor") (Borrower and/or Guarantor, as applicable, shall be referred to collectively hereinafter as "Assignor") and Partners for Growth, L.P., 180 Pacific Avenue, San Francisco, CA 94111 ("Assignee") pursuant to a Loan and Security Agreement and Cross-Corporate Guaranty dated June 8, 2005, by and among Assignor and Assignee and pursuant to certain other loan documents referenced therein (collectively, the "Loan Documents").



WHEREAS, Assignee has agreed to extend certain credit to Assignor on condition that the Assignor pledge and grant to Assignee as collateral for the Obligations (as defined in the Loan Documents) a security interest and lien in and to the Marks and all proceeds thereof and all other related claims and rights as more fully described in a certain Intellectual Property Security Agreement (the "Security Agreement") in favor of the Assignee dated June 8, 2005, by and among Assignor and Assignee;


