**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

WHEREAS, the Secured Party has at the Company's request agreed to release its security interest in all of the Company's trademarks and trademark applications, including the Listed Trademarks, and the registrations thereof and the associated business goodwill therein; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby releases its security interest in all of the Company's trademarks and trademark applications, including the Listed Trademarks, and the registrations thereof and the associated business goodwill therein and to any other rights it might have arising out of the Security Agreement. The Secured Party hereby undertakes and agrees to do such things and to execute such further lawful documents, assurances, applications and other instruments as may be required to give effective legal, registered and unencumbered title to the Company in and to the trademarks and trademark applications, including but not limited to the Listed Trademarks and the registrations thereof all without further considerations; provided that all of the foregoing shall be at the Company's sole cost and expense.


