ASSIGNMENT


Aristocrat Technologies Australia Pty Ltd., an Australia corporation whose business address is 71 Longueville Road, Lane Cove, New South Wales 2066, Australia has adopted and used the mark JACKPOT CARNIVAL, and filed with the United States Patent and Trademark Office an application for federal registration of the mark, Serial No. 76/299,554, on August 14, 2001 covering playing games of chance in International Class 9 (collectively the "JACKPOT CARNIVAL Mark").

In consideration of the foregoing, and for other good and valuable consideration, receipt of which is hereby acknowledged, Aristocrat hereby assigns to Carnival all its right, title, and interest in and to the JACKPOT CARNIVAL Mark, together with the goodwill of the business in connection with which the JACKPOT CARNIVAL Mark is used, the pending application for the JACKPOT CARNIVAL Mark, and the right to claim all benefits from use of the JACKPOT CARNIVAL Mark as though the JACKPOT CARNIVAL Mark was first used by Carnival, including the right to sue third parties for and recover damages from past and future infringement of the JACKPOT CARNIVAL Mark.
