**RELEASE OF SECURITY INTEREST
TRADEMARK(S)**

On December 18, 1997, Conley Frog and Switch Co., Inc., a Tennessee corporation ("**Conley**") granted a security interest in U.S. Trademarks Serial Number 73-172,023 and Serial Number 74-442,108 to Lyon Credit Corporation ("**Lyon**") pursuant to a loan made by Lyon to Conley. Lyon subsequently transferred its security interest to Hudson United Bank through its United Capital Division as assignee of Lyon Credit Corporation ("**Hudson**").

Lyon's security interest was evidenced by an Security Interest in Trademarks which was recorded with the United States Patent and Trademark Office on December 29, 1997 on **Reel 1673, Frame 787**. Lyon's transfer of the security interest to Hudson was embodied in an Assignment of Assignor's Interest which was recorded with the United States Patent and Trademark Office on December 23, 1999 on **Reel 2018, Frame 828**.

Pursuant to Section 3.10 of the Loan Restructuring Agreement dated as of March 17, 2005 ("**LRA**") between Hudson, Conley and James F. Goodmon ("**Goodmon**"), Hudson hereby releases its security interest in such trademark and hereby terminates its security interest evidenced by the Security Interest in Trademarks.
