ASSIGNOR HEREBY AGREES to take all actions, and to execute and deliver all additional instruments and documents, as Assignee may reasonably request for the purpose of carrying out this Assignment and the transactions contemplated herein including, but not limited to, all instruments and documents necessary to transfer the Marks in the United States and any foreign countries.


