ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

THIS ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS (this "Assignment") is dated as of April 6, 2005 and made by LASALLE BUSINESS CREDIT, LLC (successor by merger to LASALLE BUSINESS CREDIT, INC.) ("LaSalle") in favor of Patriarch Partners Agency Services, LLC ("Patriarch"), as agent to the Successor Lender referred to below.

WHEREAS, LaSalle, as lender, and the Loan Parties, as defined therein, as borrowers, are parties to that certain Loan and Security Agreement, dated as of May 15, 2002 (as amended, modified supplemented and restated from time to time, the "Loan Agreement");

WHEREAS, pursuant to that certain Trademark and Service Mark Security Agreement, dated as of October 1, 2002 (as amended, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), STONEPATH LOGISTICS GOVERNMENT SERVICES, INC., f/k/a Transport Specialists, Inc., ("Government Services"), a Loan Party under the Loan Agreement, assigned and granted to LaSalle a continuing security interest and lien on all of Government Services' right, title and interest in and to all of its trademarks, including, without limitation, the trademarks registered/filed with the United States Patent and Trademark Office listed on Exhibit A attached hereto (collectively, all of such security interests and liens of LaSalle in and to such trademarks of Government Services, the "Trademark Rights");

WHEREAS, pursuant to that certain Assignment and Acceptance, dated as of April 6, 2005, among LaSalle, as assignor, Zohar II 2005-1, Limited (the "Successor Lender"), as assignee, and the Loan Parties (including Government Services), LaSalle irrevocably sold and assigned to the Successor Lender, and the Successor Lender irrevocably purchased and assumed from LaSalle, all of LaSalle's right, title and interest in, to and under, among other things, the Loan Agreement and the Trademark Security Agreement, including the Trademark Rights;

WHEREAS, LaSalle's Trademark Rights were recorded with the United States Patent and Trademark Office on January 16, 2003 under Reel/Frame 002652/0985; and

WHEREAS, the parties now wish to effectuate the assignment of the Trademark Rights from LaSalle to Patriarch, as the agent for the Successor Lender, by filing this Assignment with the United States Patent and Trademark Office.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, LaSalle hereby assigns, grants and transfers unto Patriarch, as the agent for the Successor Lender, the Trademark Rights.

LaSalle hereby requests the Commissioner of Patents and Trademarks to record Patriarch as the assignee of the Trademark Rights.

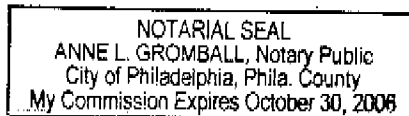
