ASSIGNMENT AGREEMENT

ASSIGNMENT AGREEMENT dated as of the 9th day of June, 2005 (the "Effective Date"), among FreeEDGAR.com, Inc. (hereinafter "Assignor"), a Delaware corporation, having its principal address at 50 Washington Street, Norwalk, CT 06854 and EDGAR Online, Inc. (hereinafter "Assignee"), a Delaware corporation, having its principal address at 50 Washington Street, Norwalk, CT 06854.

WHEREAS, Assignor is the wholly-owned subsidiary of Assignee; and

WHEREAS, Assignor through a merger became the owner of the trademark "FREEEDGAR" (the "Trademark") and the domain name www.freeedgar.com (the "Website") as well as the contents ("Website Content") of the Website; and

WHEREAS, Assignor desires to transfer all right title and interest in and to the Trademark, Website, and Website Content (together the "Properties") to Assignee and Assignee desires to accept such transfer; and

WHEREAS, the parties hereto desire to execute this Agreement to evidence the assignment by the Assignor and the assumption by the Assignee of Assignor's interest in the Properties;

NOW, THEREFORE, in consideration of the premises and the mutual agreements herein contained and for consideration the receipt and sufficiency of which is acknowledged, the parties hereto agree as follows:

1. **Assignment of Interest.** The Assignor hereby transfers, conveys, assigns and sets over to the Assignee, its successors and assigns, for its benefit and their benefit forever, all of the right, title and interest of the Assignor in the Properties free and clear of any liability, lien or encumbrance, and Assignee hereby accepts the assignment of Assignor's interest in the Properties.
2. **Representations and Warranties.** Assignor represents and warrants that pursuant to this Agreement, Assignee shall obtain good title in and to the Properties free and clear of any liability, lien or encumbrance.
3. **Further Assurances.** At any time, and from time to time after the date hereof, at the request of the Assignee, and without further consideration, the Assignor shall execute and deliver such other instruments of sale, transfer, conveyance, assignment and confirmation and take such other action as the Assignee may reasonably request as necessary or desirable in order to more effectively transfer, convey and assign the Properties to the Assignee.

4. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of New York without regard to principles of conflict of laws.

IN WITNESS WHEREOF, the parties hereto have executed this Agreement as of the Effective Date.
