ASSET PURCHASE AGREEMENT

This ASSET PURCHASE AGREEMENT ("*Agreement*"), dated as of December 5, 2001, is made and entered into by and among SIGNATURES NETWORK, INC., a California corporation ("*Buyer*"), and WINTERLAND CONCESSIONS COMPANY, a California corporation, and CONCERT CONCESSIONS CORPORATION, a California corporation (collectively, "*Seller*").

Seller desires to sell and assign to Buyer, and Buyer desires to purchase and assume from Seller, on the terms and subject to the conditions set forth in this Agreement, substantially all of the Acquired Assets (defined below) and Assumed Liabilities (defined below) of Seller that are currently being used by Seller in the conduct of the Business (the "*Acquisition*").

NOW, THEREFORE, in consideration of the mutual covenants, representations, warranties and agreements and the conditions set forth in this Agreement, Buyer and Seller hereby agree as follows:

Section 1.2 Transfer of Acquired Assets. On the terms and subject to the conditions set forth in this Agreement, Seller shall, at the Closing, sell, transfer and assign to Buyer, and Buyer shall purchase and acquire from Seller, all of Seller's right, title and interest, as of the Closing Date, in and to all of the following assets of Seller related to, or used in conjunction with, the Business (collectively, except for the excluded assets set forth in Section 1.3 hereof, the "*Acquired Assets*"):

(e) All rights in patents, patent applications, trademarks, trademark registrations, trademark applications, service marks, trade names, corporate names, logos, copyrights, copyright registrations, copyright applications, mask works, artwork (including original and separated art files), materials, models, masters, diskettes, tapes, film, copies, samples, trade secrets, domain names, websites, information that derives independent economic value, actual or potential, from not being generally known to the public or to other Persons who can obtain economic value from its disclosure or use (which includes information about Seller's customers, suppliers, licensors, licensees, distributors, and other Persons with whom Seller does business), all of the other proprietary rights that Seller owns, and/or that it uses in connection with the Business including, without limitation, those set forth in Schedule 1.2(e) and including the rights to institute or maintain any action or investigation for and to recover damages for any past infringement thereof or any actions of unfair competition relating thereto;

(f) The names "Winterland" and "Winterland Concessions Company" and any other combination of words in which the name "Winterland" appears, all rights associated with such names, and all rights to use such name in all jurisdictions in which Seller either currently uses any such name or has any right to use any such name. Seller covenants and agrees that by Closing, it will have executed such documents and instruments as are necessary and appropriate to change its corporate name (from "Winterland Concessions Company" to a name that does not include all or any portion of the word "Winterland" and is not similar to the word "Winterland"), and at Closing will provide true and correct copies of same to Buyer. Seller covenants and agrees that it will effect the change to its corporate name promptly after Closing.




