
WHEREAS Assignor is the owner of the trademark registration for the Mark (the "Registration") set forth in Exhibit 1 and incorporated herein by reference; and

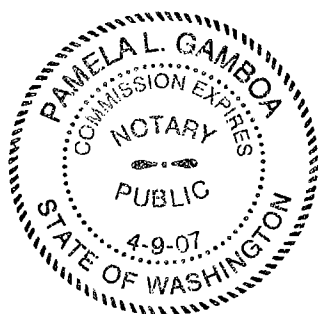
