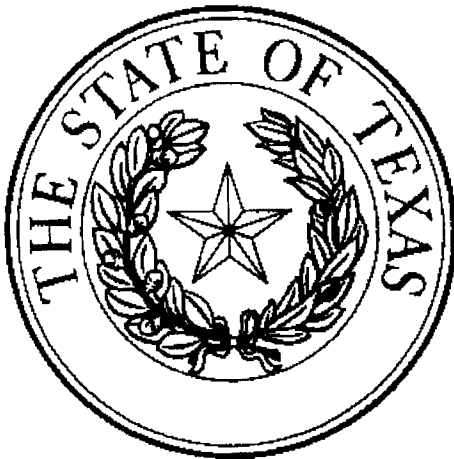

Article 1 –Name
