**CONFIRMATION OF
TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This CONFIRMATION OF TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Confirmation ") is executed and delivered as of the 8/16 day of September, 2004 by U.S. Bank National Association (successor in interest to State Street Bank and Trust Company) ("U.S. Bank") to Hollywood Casino Corporation, a Delaware corporation (the "Company").

BACKGROUND

A. Pursuant to that certain Indenture dated as of October 17, 1995 (the "Indenture") among the Company, HWCC-Tunica, Inc, and Shawmut Bank, National Association ("Shawmut") as Trustee (the "Trustee"), the Company issued \$210,000,000 of its 12 3/4% Senior Secured Notes due November 1, 2003 (the "1995 Notes").

B. Shawmut in its capacity as Trustee was succeeded by Fleet National Bank ("Fleet") pursuant to a merger. Subsequently, substantially all of the corporate trust business of Fleet was acquired by State Street Bank and Trust Company ("State Street"). On December 31, 2002, U.S. Bank acquired State Street's corporate trust business.

C. Pursuant to the Indenture, the Company entered into a Security Agreement dated as of October 17, 1995, as amended by the First Amendment and Supplement to Security Agreement dated as of November 15, 1995, and the Second Amendment and Supplement to the Security Agreement dated as of January 14, 1999 (collectively, the "Security Agreement").

D. Pursuant to the Security Agreement, the Company granted the Trustee a security in its trademarks, including those set forth on Exhibit A attached hereto and made a part hereof, and said security interests were, or were to be, recorded with the U.S. Patent and Trademark Office ("US PTO").

E. In connection with the Company's subsequent issuance of its \$310,000,000 11 1/4% Senior Secured Notes due 2007 and \$50,000,000 Floating Rate Senior Secured Notes due 2006 (collectively, the "1999 Notes"), the Company satisfied and discharged its obligations under the 1995 Notes on May 19, 1999. Attached hereto as Exhibit B are documents evidencing the satisfaction and discharge of the Company's obligations under the 1995 Notes.

F. In connection with the 1999 Notes, the Company executed and delivered to the Trustee that certain Trademark Security Agreement (the "1999 Security Agreement"). Pursuant to the 1999 Security Agreement, the Company granted the Trustee a security interest in its trademarks (the "1999 Security Interest"), including those set forth in Exhibit C attached hereto. Exhibit C includes all of the trademarks included in Exhibit A.

G. The 1999 Security Interest was recorded with the U.S. Patent and Trademark Office.

H. Pursuant to those certain wire transfers in the aggregate amount of \$401,612,187.50 to that certain escrow account of U.S. Bank, the Company satisfied and discharged its obligations under the 1999 Notes on March 4, 2003.

I. On March 3, 2003, U.S. Bank, as the successor in interest Trustee, executed and delivered to the Company the Termination and Release of Security Interest in Trademarks ("Termination and Release"), terminating and releasing the 1999 Security Interest. A true and correct copy of the Termination and Release is attached hereto as Exhibit D.

NOW THEREFORE, with the foregoing Background incorporated by reference and intending to be legally bound hereby, the parties agree as follows:

1. U.S. Bank as the successor in interest to the Trustee hereby confirms the termination and release of all of the Trustee's right, title and interest in the trademarks described in the Security Agreement, including those set forth in Exhibit C.

2. The Company, or its designee, may record this Confirmation in the US PTO and in any other trademark offices as may necessary to carry out the intentions of this Confirmation.

3. U.S. Bank agrees to execute and deliver such other documents as may be reasonably requested and prepared by the Company, or its designee, to carry out the intentions of this Confirmation.



TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** ("Termination") is executed and delivered as of the 3rd day of March, 2003 by U.S. Bank National Association, as successor trustee under the Indenture referred to below ("Trustee"), to Hollywood Casino Corporation, a Delaware corporation ("Hollywood").

BACKGROUND

A. Hollywood, as issuer, HWCC-Tunica, Inc. and HWCC-Shreveport, Inc., as guarantors, and Trustee entered into that certain Indenture, dated as of May 19, 1999 (the "Indenture")

B. In connection with the Indenture, on May 19, 1999, Hollywood executed and delivered to Trustee that certain Trademark Security Agreement (the "Hollywood Security Agreement").

C. Pursuant to the Hollywood Security Agreement, Hollywood granted to Trustee a security interest in the trademarks set forth on Exhibit A attached hereto (the "Security Interest").

D. The Security Interest was recorded in the United States Patent and Trademark Office ("USPTO") as set forth on Exhibit A attached hereto.

E. Hollywood has satisfied all of its obligations secured by the Hollywood Security Agreement.

NOW THEREFORE, with the foregoing Background incorporated by reference and intending to be legally bound hereby, the parties agree as follows:

1. Trustee hereby terminates and releases all of its rights, titles and interests in the trademarks set forth on Exhibit A.

2. Hollywood, or its designee, may record this Termination in the USPTO and in any other trademark offices as may necessary to carry out the intentions of this Termination.

3. Trustee agrees to execute and deliver such other documents as may be reasonably requested and prepared by Hollywood, or its designee, to reconfirm full title to the trademarks in Hollywood.
