DOES HEREBY CERTIFY:

FIRST: That this corporation was incorporated on the 14th day of December, 1992, pursuant to the General Corporation Law of the State of Delaware.

SECOND: That this corporation owns all of the outstanding shares of the stock of TFS Database Group, Inc., a corporation incorporated on the 12th day of July, 1979, pursuant to the General Corporation Law of the State of Delaware.

THIRD: That this corporation, by the following resolutions of its Board of Directors, duly adopted by the unanimous written consent of its members, filed with the minutes of the board on the 20th day of November, 1995, determined to and did merge into itself said TFS Database Group, Inc.:

RESOLVED, that the Corporation hereby merges into itself TFS Database Group, Inc., and assumes all the obligations; and

FURTHER RESOLVED, that the merger shall be effected on December 31, 1995; and be it

FURTHER RESOLVED, that each outstanding share of TFS Database Group, Inc. on the effective date of the merger, shall be surrendered and cancelled. No shares of the survivor, American Banker Inc. shall be issued in exchange.
