**CERTIFICATE OF AMENDMENT  
TO  
AMENDED AND RESTATED  
CERTIFICATE OF INCORPORATION

**Pursuant to Section 242 of the  
Delaware General Corporation Law**

awayX Solutions, Inc., (the "Corporation"), originally incorporated as awayX.com, Inc., a corporation organized and existing under and by virtue of the provisions of the Delaware General Corporation Law (the "DGCL"),

DOES HEREBY CERTIFY:

**FIRST:** That an Amended and Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on November 22, 2000.

**SECOND:** That the Board of Directors duly adopted resolutions proposing to amend certain provisions of the Amended and Restated Certificate of Incorporation of the Corporation, declaring said amendments to be advisable and in the best interests of the Corporation and its stockholders, and authorizing the appropriate officers of this Corporation to solicit the consent of the stockholders therefor, all in accordance with Section 242 of the DGCL.

**THIRD:** That the stockholders of the Corporation have voted to approve such amendments, all in accordance with Sections 228 and 242 of the DGCL.

**FOURTH:** That the resolutions setting forth the proposed amendments are as follows:

**RESOLVED,** that the Amended and Restated Certificate of Incorporation of the Corporation be amended as follows:

1. That Article FIRST, setting forth the name of the Corporation be, and hereby is, deleted and restated in its entirety as follows:

The name of the corporation is: Blacksmith Applications, Inc.

2. That the references to One Million Four Hundred Twenty Eight Thousand (1,428,000) in Article FOURTH, Sections A.6(c) and A.8(i), be, and hereby are, deleted and replaced with the number One Million One Hundred Forty Four Thousand (1,144,000).

3. Every other Article and provision in the Amended and Restated Certificate of Incorporation remains in full force and effect.
