TRADEMARKS ASSIGNMENT

THIS ASSIGNMENT OF TRADEMARKS, dated as of June 1, 2005 (this "Assignment"), by International Paper Company ("Assignor"), a New York corporation with its principal place of business at 400 Atlantic Street, Stamford, CT 06921 in favor of Thilmany, LLC, formerly known as TIPB Acquisition, LLC, a Delaware limited liability company with its principal place of business at 600 Thilmany Road, Kaukauna, WI 54130.

WHEREAS, Assignor and Assignee are parties to that certain Purchase Agreement, dated as of March 14, 2005 (the "Purchase Agreement"), pursuant to which Assignor has agreed to transfer to Assignee and Assignee has agreed to accept from Assignor certain of the assets including, but not limited to trademarks, trade names, labels and other trade dress and copyrights (including goodwill associated therewith), exclusively relating to the Business (as defined in the Purchase Agreement) and to become the successor to such Business or portion thereof to which any trademark applications filed on the basis of "intent-to-use" relate, which Business is ongoing and existing;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign, transfer, set over, and deliver to assignee all of Assignor's right, title, and interest, in and to:

- (i) the trademarks, trade names, labels and other trade dress set forth on Schedule A hereto, including all registrations and applications thereof, all registrations which may be granted in respect of such applications, all renewals of such registrations, and all common law rights therein;
- (ii) the goodwill of the business symbolized by such trademarks;
- (iii) all causes of actions, claims and demands or other rights for, or arising from, any infringement, including past infringement, of such trademarks and other items set forth on Schedule A; and
- (iv) all rights corresponding thereto throughout the world.





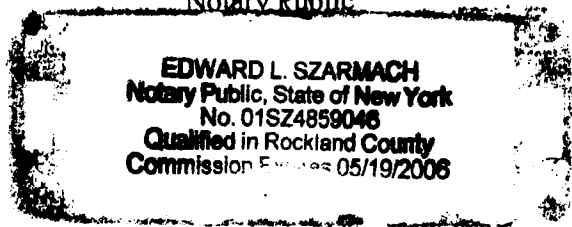
