ASSIGNMENT OF INTELLECTUAL PROPERTY

THIS ASSIGNMENT is made as of July 31, 2000 by SunDance Rehabilitation Corporation, a Connecticut corporation ("SunDance"), in favor of John C. Castel, an individual ("Castel"), John B. Beach, an individual ("John Beach"), and Curtis Beach, an individual ("Curtis Beach") (Castel, John Beach and Curtis Beach are collectively referred to herein as "Buyer").

RECITALS

WHEREAS, pursuant to that certain Purchase Agreement (as defined below), Buyer and SunDance wish to assign to Buyer the entire right, title and interest in, to and under the patents, trademarks, copyrights, applications and other intellectual property set forth in the attached Schedule A, together with all foreign rights corresponding thereto, any reissues, extensions, substitutions, confirmations, divisions and continuations of any of the foregoing and all the rights to sue and recover for past infringement thereof (the "Assigned Intellectual Property Rights"); and

WHEREAS, Buyer and SunDance wish to ensure that Buyer has acquired all right, title and interest in and to the Assigned Intellectual Property Rights;

NOW, THEREFORE, for good and valuable consideration as contained in the Settlement and Purchase Agreement dated the date hereof among SunDance, Sun Healthcare Group, Inc., Accelerated Care Plus, L.L.C., Buyer and Dawn Castel (the "Purchase Agreement"), the receipt and sufficiency of which is hereby acknowledged, SunDance does hereby sell, assign, transfer and convey to Buyer its entire right, title and interest in and to the Assigned Intellectual Property Rights, to have and to hold for the sole and exclusive use and benefit of Buyer forever.

SunDance hereby covenants and agrees, for itself and for its legal representatives, to assist and cooperate with Buyer in the preparation and prosecution of any applications included within the Assigned Intellectual Property Rights in the prosecution or defense of any interference, opposition or other proceeding that may arise in connection with the applications or other intellectual property included within the Assigned Intellectual Property Rights, subject to appropriate reimbursement for expenses and time incurred in such assistance, and further to execute and deliver to Buyer any and all additional papers that may be requested by Buyer for the purpose of implementing the terms of this Agreement.

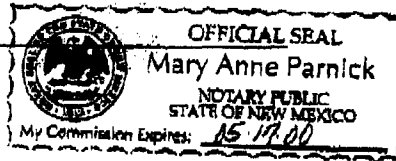
