WHEREAS, on September 6, 2001, Assignors filed applications serial nos. 76/309,843 and 76/311,996 before the U.S. Patent and Trademark Office to register the name and mark Patriots Energy Group as described therein ("PEG Marks");

WHEREAS, on July 9, 2003, Assignors formed PEG as a Joint Action Agency under South Carolina law to carry out the business Assignors were jointly undertaking under the Patriots Energy Group name;

WHEREAS, now that PEG is a recognized Joint Action Agency comprised of Assignors, Assignors desire that PEG have and use the PEG Marks while carrying out PEG's business; and

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, Assignors do hereby assign all their interest, right and title in and to the PEG Marks to PEG. PEG will be the real party in interest and responsible for defense or resolution of Notices of Opposition nos. 91159882 and 91159855 filed by Richland Partners, LLC before the Trademark Trial and Appeal Board against the registration the PEG Marks.
