TRADEMARK ASSIGNMENT

RECITALS

C. Assignor is willing to assign to Assignee all rights, title and interest in Trademark, including any common law rights, trade name rights and rights to recover for past infringement, if any.

For good and adequate consideration, which is hereby acknowledged, Assignor hereby assigns to Assignee all rights, title and interest as Assignor may possess in and to the following:

2. The goodwill symbolized by the Trademark and Registration, and any other value which the Trademark possesses.

3. Assignor hereby warrants and represents to Assignee as follows:

(a) Assignor is the sole legal and beneficial owner of Fifty Percent (50%) interest in the Trademark.

(b) Assignor warrants that she has the full power to transfer her Fifty Percent (50%) interest to Assignee.

(c) To the best of Assignor's knowledge, the transfer of her Fifty Percent (50%) interest in the Trademark will not conflict with, or violate any agreements or law to which Assignor is subject to.

4. This Assignment shall be binding on, and shall inure to the benefit of the parties to it and their respective heirs, legal representatives, successors, and assigns.


5. The Recitals set forth above are hereby incorporated into this Assignment.
