THIS DEED OF ASSIGNMENT is made the *9th* day of *JULY* 2002

**BETWEEN:**

- (1) OMG UK Limited a company incorporated in England and Wales whose registered office is at 400 Capability Green, Luton, Bedfordshire, LU1 3LU (the "Assignor"); and
- (2) OMG ACQUISITIONS II, INC. a company incorporated in the State of Delaware with its primary place of business at 50 Public Square, Suite 3500, Cleveland, OH 44113-2204, USA (the "Assignee").

**THIS DEED WITNESSES** as follows:

**1. INTRODUCTION**

The Assignor is the proprietor and beneficial owner of the trade marks specified in the Schedule to this Deed of Assignment (the "Trade Marks").

**2. ASSIGNMENT OF TRADE MARKS**

2.1 In consideration of the sum of one pound sterling (£1) (receipt of which is hereby acknowledged) the Assignor hereby assigns to the Assignee with full title guarantee the Trade Marks, including all statutory and common law rights attaching to the Trade Marks and the right to take action in respect of past infringements of the Trade Marks and to retain any damages obtained as a result of such action.

2.2 The Assignor confirms that this Deed of Assignment is made with the goodwill attaching to the Trade Marks and the goodwill of the business in which the Trade Marks have been used by the Assignor.

2.3 The Assignor shall at the reasonable request and expense of the Assignee do all acts and execute all documents in order to vest the Trade Marks in the Assignee.

**3. LAW & JURISDICTION**

This Deed of Assignment shall be governed by and construed in accordance with English law and the parties submit to the exclusive jurisdiction of the English courts.


