Pursuant to Section 14-2-1105(b) of the Georgia Business Corporation Code (the "GBCC"), it is hereby certified, on behalf of each of the Constituent Entities (as defined below) herein named as follows:

I.

The name of the constituent entity which is to be the surviving entity is Optio Software, Inc., a Georgia corporation (hereinafter sometimes called the "*Surviving Entity*").

II.

The name of the constituent entity which is being merged (the "*Merger*") with and into the Surviving Entity is VertiSoft Corporation, a Georgia corporation (hereinafter sometimes called the "*Merged Entity*"). The Surviving Entity and the Merged Entity are hereinafter sometimes referred to collectively as the "*Constituent Entities*".

III.

VertiSoft Corporation is a wholly-owned subsidiary of Optio Software, Inc. The Merger has been duly approved through official actions taken by the Boards of Directors of Optio Software, Inc. and VertiSoft Corporation, and pursuant to Section 14-2-1104 of the GBCC, approval is not required by the shareholders of either Constituent Entity.

IV.

An executed copy of the Plan of Merger is on file at the principal place of business of the Surviving Entity, located at 3015 Windward Plaza, Windward Fairways II, Alpharetta, Georgia 30005. A copy of the Plan of Merger will be furnished by the Surviving Entity, on request and without cost, to any shareholder of either Constituent Entity.

V.

The Articles of Incorporation and Bylaws of Optio Software, Inc. immediately prior to the

Merger shall continue to be the Articles of Incorporation and Bylaws of the Surviving Entity from and after the Merger and shall not, as of this time, be amended.

VI.

The request for publication of a notice of filing of this Certificate of Merger and payment therefor will be made as required by Section 14-2-1105.1(b) of the GBCC.

VII.

The Merger shall become effective as of the time this Certificate of Merger is filed with the Secretary of State of the State of Georgia.
