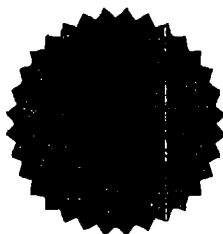

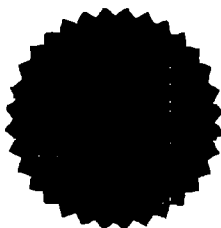

Article I is hereby amended to read in its entirety as follows:

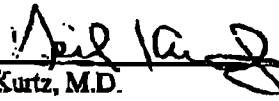
"The name of the corporation is TorreyPines Therapeutics, Inc."
