

**FEDERAL TRADEMARK ASSIGNMENT**





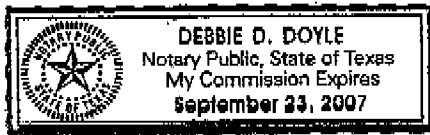
