## USCO SONY TRADEMARK ASSIGNMENT

USCO SONY TRADEMARK ASSIGNMENT dated as of August 5, 2004 by Sony Music Entertainment Inc., a Delaware corporation ("Assignor") and USCO Holdings Inc., a Delaware corporation ("Holdings"), in favor of Sony BMG Music Entertainment, a Delaware general partnership ("Assignee").

WHEREAS, Assignor is the owner of the trademark registrations and applications listed on Schedule I attached hereto for the goods and/or services identified therein (the "Marks").

WHEREAS, pursuant to the Contribution Agreement, dated as of December 11, 2003, by and between Sony Corporation of America, a New York corporation ("Sony America"), and Bertelsmann AG, a German corporation, as in effect from time to time, Sony America agreed to contribute, or cause to be contributed, to Assignee certain of its rights in and to its recorded music business, including the Marks;

WHEREAS, pursuant to the USCO Holdings Contribution Agreement, dated the date hereof, between Assignor and Holdings, Assignor assigned all of its right, title and interest in and to the Marks to Holdings;

WHEREAS, simultaneously with such assignment, and pursuant to the Sony USCO Contribution Agreement, dated the date hereof, between Holdings and Assignee, Holdings assigned to Assignee all of its right, title and interest in and to the Marks to Holdings; and

WHEREAS, Assignor, Holdings and Assignee wish to record the foregoing assignment in the United States Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

### TRANSFER FROM ASSIGNOR TO HOLDINGS

1. Assignor hereby sells, grants, conveys, assigns and transfers to Holdings, its successors and assigns, all right, title and interest now owned or hereafter acquired by Assignor in the Marks, including without limiting the generality of the foregoing:
  - (a) the goodwill of the business symbolized by and associated with the Marks;
  - (b) the portion of Assignor's business in connection with which it has a bona fide intent to use those Marks that were filed on an intent-to-use basis and for which an Amendment to Allege Use or a Statement of Use has not yet been filed and accepted by the relevant Trademark Office or other governing authority; and

- (c) all rights to proceeds of the foregoing, including, without limitation, any claim by Assignor against third parties for past, present, or future infringement of the Marks, and all rights to and claims for sums due Assignor for the past, present or future exploitation of the Marks.

#### **TRANSFER FROM HOLDINGS TO ASSIGNEE**

- 2. Holdings hereby sells, grants, conveys, assigns and transfers to Assignee, its successors and assigns, all right, title and interest now owned or hereafter acquired by Holdings in the Marks, including without limiting the generality of the foregoing:
  - (a) the goodwill of the business symbolized by and associated with the Marks;
  - (b) the portion of Holdings' business in connection with which it has a bona fide intent to use those Marks that were filed on an intent-to-use basis and for which an Amendment to Allege Use or a Statement of Use has not yet been filed and accepted by the relevant Trademark Office or other governing authority; and
  - (c) all rights to proceeds of the foregoing, including, without limitation, any claim by Holdings against third parties for past, present, or future infringement of the Marks, and all rights to and claims for sums due Assignor for the past, present or future exploitation of the Marks.

#### **MISCELLANEOUS**

- 3. This Trademark Assignment shall be governed and construed according to the laws of the State of New York as if it were wholly executed and wholly performed within the State of New York, without reference to its conflicts of law principles, and the trademark laws of the United States, as applicable.
- 4. This Trademark Assignment may be executed in one or more counterparts, each of which shall be deemed to be an original but all of which together shall constitute one and the same instrument.


