TRADEMARK ASSIGNMENT AGREEMENT

B. The parties desire that MGI own the Marks and that TECI assign the Marks under the terms and conditions of this Agreement.


In consideration of the above recitals and the promises set forth in this Agreement, the parties agree as follows:
