DECLARATION:

In compliance with TMEP Chapter 503.06(c)

1. My name is Francisco David Coll, aka Francisco David Coll Schwab. My current residence is 1447 HWY 69, PO Box 252, Osceola, Iowa 50213. I am the sole heir, Judicial Administrator & General Executor for the Estate of Francisco Coll Monge (a Puerto Rico Estate), and I am United States Citizen.
2. My father, Dr. Francisco Coll aka Francisco Coll Monge, was the applicant and owner of 17 Registered Marks, as well as over 40 common law Marks. Dr. Coll created, used and controlled these marks for over 35 years, in both for profit and nonprofit use and commerce world wide until his death on 15 December 1999. Since his passing, his Estate has consistently continued to use and control the above Marks directly and through multiple licensees in the US and internationally. To enforce and protect our registrations the Estate has had to pursue and sue multiple entities and individuals that have infringed our trademark that formerly worked for my father, Dr. Francisco Coll.
3. PURPOSE: The purpose in this declaration is to correct, what I believe to be multiple incomplete, false and fraudulent assignment coversheets in registration numbers: 1,899,284 (Peace Community Church), 1,806,494 (Dove design), 1,894,364 (Inner Peace Movement), 1,801,163 (IPM plus design), returning the "last listed owner" and "Last Applicant/Owner of Record" back to the above Estate or my name in various capacities relating to the above Estate, as shown in previous assignments. The above Estate, or Francisco David Coll, has been and continues to be the last correct assignee and owner of the registrations (TMEP 503.06(c)).
4. BASIS OF CORRECTION: On or about May 14, 2004, student counsel for defendants (Inner Peace Movement, Inc. and Peace Community Church, Inc.), their American University (AU) student attorneys or their professor began filing what became two to five assignment coversheets per registration by January 30, 2005. No assignments of the subject registrations have been executed by my father, Dr. Coll, or by me in behalf of his Estate to Inner Peace Movement, Inc. or Peace Community Church, Inc.
5. There have been no court rulings authorizing or directing transfer of title from the Executor, Francisco David Coll or the Estate of Francisco Coll Monge to any third party, especially the defendants Inner Peace Movement, Inc. or Peace Community Church, Inc. There has been no authorization or direction for the Commissioner of Trademarks to transfer title of these registrations either.
6. The students and later an AU professor claimed on these coversheets that they were assignments, yet there were no assignment documents executed in writing by the estate, its representatives, above defendant counsel or anyone else. Furthermore I believe the defendants AU student and academic counsel knew there were no legal assignment documents attached, therefore what they did was both false and fraudulent.
7. It is my belief after researching these filings and related correspondence from our attorney to Washington School of Law (AU), that the so called assignments intended to deceive the USPTO in general and the USPTO Assignment Division in particular. Unfortunately they

have been successful. Because of multiple thefts , conversion of property, as well as infringement of copyrights and trademarks, the Estate was forced sue Inner Peace Movement, Inc. and Peace Community Church, Inc., as well as multiple directors of the above organizations in February 2001. This matter is active, ongoing and currently being heard in the US Court of Appeals for the District of Columbia Circuit (Case#: 04-7053), after a interlocutory (not definitive) decision in the US District Court for the District of Columbia. (See case#: 1:01-cv-00271-EGS).

8. CORRECTION OF ASSIGNMENTS:

The following corrections are made as directed by TMEP 503.06(c), as suggested by the Office of Commissioner of Trademarks in May of 2005.

Due to the organizations, Inner Peace Movement, Inc and Peace Community Church, Inc, or their counsel's unwillingness to correct these erroneous and misleading assignments, the Estate is forced to file these corrective documents.

The following reel and frame numbers I believe contain erroneous, misleading and fraudulent claims and assertions:
