RELEASE OF TRADEMARKS

THIS RELEASE OF TRADEMARKS, granted on this 15th day of March, 2004, is delivered by **BANK OF MONTREAL, CHICAGO BRANCH**, in its capacity as agent for and representative of the Lenders referred to below (in such capacity, "**Secured Party**") under the Security Agreement referred to below, to **WICKS BUSINESS INFORMATION, LLC**, a Delaware limited liability company ("**Grantor**").

WITNESSETH

WHEREAS, Grantor, the other grantors from time to time party thereto and Secured Party have entered into an Amended and Restated Security Agreement (the "**Security Agreement**"), dated as of October 12, 2001, pursuant to which Grantor granted to Secured Party a security interest in, among other things, the trademarks, together with the registrations and right to all renewals thereof, and the goodwill of the business of Grantor symbolized by the trademarks, trademark applications, trade names and service marks, (collectively, the "**Trademarks**"), more particularly set forth on Schedule A hereto, to secure the obligations of the Grantor to the Secured Party;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby releases, discharges, quit claims and relinquishes unto the Grantor any and all right, title and interest in, to and under the Trademarks set forth on Schedule A hereto granted to the Secured Party by the Grantor pursuant to the IP Supplement.


