TRADEMARK ASSIGNMENT

This Trademark Assignment (the "*Agreement*") is entered into as of June 1, 2002, by and between First Cash Financial Services, Inc., a Delaware corporation ("*First Cash*"), and Tumbleweed Software, Inc., a Texas corporation having an address at 2506 Gravel Drive, Building 18, Fort Worth, Texas 76118 ("*Tumbleweed*").

WHEREAS, First Cash is the owner of the trademark ANSWERS, ETC., including U.S. Trademark Registration No. 2,343,689 therefor (the "*Trademark*");

WHEREAS, First Cash has sold the business related to the Trademark and desires to assign the Trademark to Tumbleweed, the current owner of the business;

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follow:

1. **Assignment.** First Cash hereby assigns, transfers and conveys to Tumbleweed all of First Cash's right, title and interest in and to the Trademark, in the United States and elsewhere, including the right to sue for past infringement, together with the goodwill of the business symbolized by the Trademark.

2. **Binding Effect.** This Agreement, and all the terms and provisions hereof, shall be binding upon and shall inure to the benefit of the parties, and their respective successors and assigns.
