The undersigned declares that on June 17, 2005 he was appointed as counsel of record in

the above identified Trademark Registration 838,161.

Trademark Registration 838,161 is owned by WALDORF CORPORATION, a

corporation organized under the laws of the Minnesota, located and doing business at 2250

Wabash Avenue, St. Paul, MN 55114. Because of a recording error of the U.S. Patent and

Trademark Office, that ownership is no longer properly shown by the Abstract of Title

documents recorded in the U.S. Patent and Trademark Office relating to it.

The records of the U.S. Patent and Trademark Office show Waldorf Corporation as

owner of Trademark Registration 838,161 as of the recordation of an assignment executed

October 1, 1987 which was recorded April 20, 1992 at Reel/Frame 0863/0641 (Assignment 4 on

the "Trademark Office Abstract of Title" as reflected in the USPTO on-line assignment records

(see screen shot of the Abstract attached as Appendix A).

Waldorf Corporation has noted that Assignment 6 listed on the Abstract is entirely

unrelated to either Waldorf Corporation or Trademark Registration 838,161. That Assignment

which was executed January 27, 1995 and recorded February 7, 1995 is an assignment of certain

applications and registrations from Allan N. Shine, Receiver in Bankruptcy for Rau Fastener

Company to Rau Fastener Company following a bankruptcy (See copy attached as Appendix B).

Assignment 6 does not refer to Waldorf Corporation or Trademark Registration 838,161. The

Trademark Assignment Assignee Details for Rau Fastener Company LLC (See copy attached as Appendix C) incorrectly lists Registration 838,161 as one of the registrations affected by the January 27, 1995 Assignment from the Bankruptcy Receiver to Rau Fastener.

Correction of the Abstract for the Waldorf Trademark Registration 838161 by deleting Assignment 6 from the Assignment Documents linked to it is requested. All reference to Trademark Registration 838,161 should also be deleted from The Trademark Assignment Assignee Details for Rau Fastener.

In addition to making the corrections identified in the previous paragraph, the TEAS status information for Trademark Registration 838,161 should be corrected so that the name of the order of the mark reads "Waldorf Corporation" rather than "Waldort Corporation" (See TEAS status information enclosed as Appendix D).

Clearly, recording the Assignment 6 against the above-identified Registration was due to a USPTO error. The above identified registration should never have had its chain of title affected in any manner the incorrect recording of the assignment.

Waldorf Corporation has been and continues to be the owner of the application or registration at issue.



ASSIGNMENT OF TRADEMARKS
