DOES HEREBY CERTIFY:

FIRST: Pursuant to written consent of the Board of Directors of BELLEVUE DATA COMMUNICATIONS, INC., resolutions were duly adopted setting forth a proposed amendment of the Certificate of Incorporation of said corporation, declaring said amendment to be advisable and calling a meeting of the stockholders of said corporation for consideration thereof. The resolution setting forth the proposed amendment is as follows:

"RESOLVED, that the Certificate of Incorporation of this corporation be and is hereby amended by deleting Article FIRST thereof in its entirety and by substituting in lieu thereof the following:

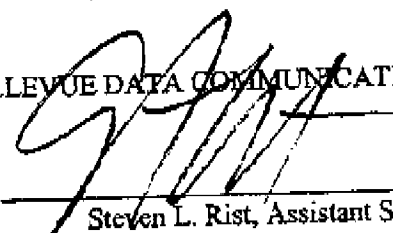
FIRST: The name of the corporation is Old BDC, Inc.
