THIS DEED OF ASSIGNMENT is made this 18th day of DECEMBER 2001

BETWEEN

(1) "the Assignor" FOSBEL INC whose principal office is at 640 North Rocky River Drive Berea Ohio 440147 USA;

AND

(2) "the Assignee" FOSBEL INTELLECTUAL AG whose registered office is at Bahnhofstrasse 16 Pfäffikon Switzerland.

WHEREAS

- (A) The Assignor is the proprietor of the trade marks set out in the Schedule hereto ("the Trade Marks") and the Assignor has agreed to assign the Trade Marks to the Assignee.
- (B) It is the intention of the parties that this document should be executed as a deed.

NOW THEREFORE IT IS AGREED

- 1. The Assignor hereby assigns to the Assignee all of the Assignor's right title and interest in and to the Trade Marks with such goodwill in the goods in respect of which the Trade Marks are registered as attaches to the Trade Marks with effect from the date hereof.

- 3. This Agreement shall be governed by and construed and interpreted in accordance with the laws of Belgium. Any litigation relating to the conclusion validity interpretation or performance of this Agreement or of subsequent contracts or operations derived herefrom as well as any other litigation concerning or related to this Agreement without any exception shall be submitted to the exclusive jurisdiction of the Brussels Courts.




