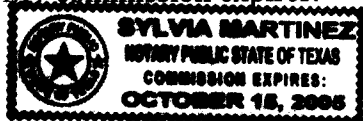

This assignment is effective as of January 31, 2003.






