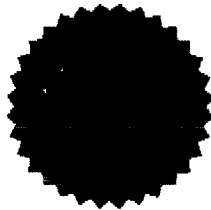

"1. The name of the corporation is GOSS INTERNATIONAL AMERICAS, INC."

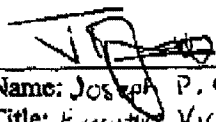
**THIRD:** That the amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.
