**ASSIGNMENT OF UNITED STATES

**NOW, THEREFORE**, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, *ASSIGNOR* has agreed to and does hereby irrevocably assign to *ASSIGNEE* all of *ASSIGNOR*'S right, title and interest in and to said *TRADEMARK RIGHTS* together with the goodwill of the business of *ASSIGNOR* in connection with which the *TRADEMARK RIGHTS* are used and which is symbolized by the *TRADEMARK RIGHTS*, along with the right to recover for damages and profits for past infringements thereof, and the registration thereof;

**ASSIGNOR** hereby authorizes the Commissioner of Patents and Trademarks of the United States to issue the *TRADEMARK RIGHTS* to *ASSIGNEE* in accordance with the terms of this instrument.

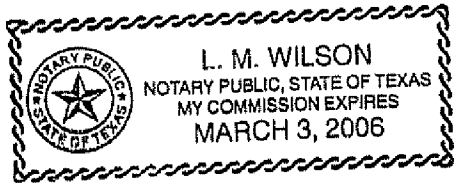

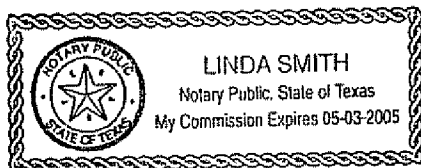
