TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS

TERMINATION AND RELEASE dated as of June 28, 2005, from Technology Investment Capital Corp., a Maryland corporation ("TICC") to WinZip International LLC, a Delaware limited liability company and successor in interest to WinZip Computing, Inc., a Connecticut corporation (the "Company"), located at 11 Professional Park Road, Mansfield, Connecticut 06268.

WITNESSETH:

WHEREAS, pursuant to the Trademark Security Agreement dated as of January 4, 2005, in favor of TICC (the "Security Agreement"), a security interest was granted by the Company to TICC in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on January 20, 2005, at Reel 3012 and Frame 0811; and

WHEREAS, TICC now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this termination and release, TICC hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Company's right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on Schedule A hereto). The term "Trademarks" shall have the meaning provided by reference in the Security Agreement.


2. Release of Security Interest. TICC hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of TICC in such Trademark Collateral shall hereby cease and become void.

3. Representations and Warranties. TICC represents and warrants that: (i) it has the full power and authority to execute this termination and release; and (ii) it has not assigned, transferred, restricted or otherwise encumbered any Security Interest it has against the Trademark Collateral.

4. Further Assurances. TICC hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

IN WITNESS WHEREOF, the undersigned has executed this termination and release by its duly authorized officer as of the date first above written.
