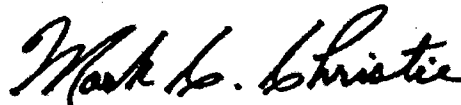

"The name of the Corporation is AFBS, Inc."

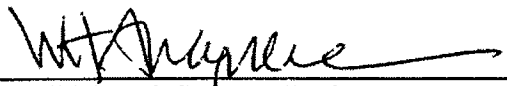
THREE

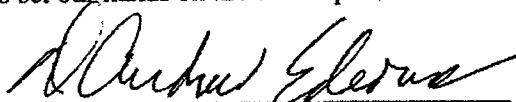

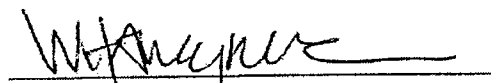
