**NOW THEREFORE**, for the sum of ten dollars U.S. (\$10.00) to be paid to Assignor by Assignee, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign, transfer and convey to Assignee all right, title, and interest in and to the Trademarks and all common law rights thereto, including any goodwill of the business symbolized by the Trademarks, together with all rights and privileges granted and secured thereto, and the right to recover for past infringement of the Trademarks, said rights to be held and enjoyed by the Assignee, for its own use and benefit and that of its successors, assigns and other legal representatives as fully and entirely the same would have been held and enjoyed by the Assignor if this Trademark Assignment had not been made.

Assignor hereby agrees to execute and deliver to Assignee any further documents, instruments, papers, forms and authorizations and to take all other actions that may be necessary for transferring, securing or vesting in Assignee full right, title and interest in and to the Trademarks.

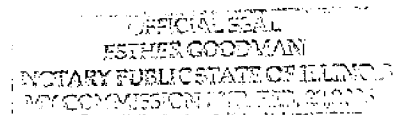
