NOTICE OF TRADEMARK SECURITY AGREEMENT
(FOR RECORDATION PURPOSES)

This Notice of Trademark Security Agreement, dated as of April 29, 2005, is made by and between HYGIENE SYSTEMS, INC., a North Carolina corporation d/b/a Omnisystems, whose address and principal place of business is 910 Rockingham Road, Rockingham, North Carolina 28379 (the "Debtor"), and FIRST BUSINESS CAPITAL CORP, a Wisconsin corporation, whose address and principal place of business is 401 Charming Drive, Madison, Wisconsin 53719 (the "Secured Party").

R E C I T A L S:

The Debtor and the Secured Party have entered into a Loan and Security Agreement dated as of April 29, 2005 (as the same may hereafter be amended, supplemented or restated from time to time, the "Loan Agreement") setting forth the terms on which the Secured Party may now or hereafter make certain loans or other financial accommodations to or for the account of the Debtor.



IN WITNESS WHEREOF, the parties have executed this Notice of Trademark Security Agreement as of the date written above.



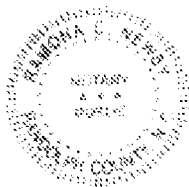
