NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby assign, transfer and sell unto Assignee, all right, title and interest of Colony and the Assignor in and to the Marks, together with the good will of the business symbolized by the Marks, and the registrations of the Marks.
