**ARTICLES OF
AMENDMENT TO THE
ARTICLES OF INCORPORATION
OF
NITRO SPORTS CORP.
a Texas Corporation**

The following amendment to the Articles of Incorporation of Nitro Sports Corp., a Texas corporation, is adopted pursuant to the provisions of Article 6.04 of the Texas Business Corporation Act, as amended.

I.

The name of the corporation is **NITRO SPORTS CORP.**

II.

1. Article One of the Articles of Incorporation is hereby amended to read in its entirety as follows:

"The name of the corporation is **COLLEGIATE PACIFIC INC.** (the "Corporation").

III.

The foregoing amendment was adopted by the sole shareholder of the Corporation by written consent effective August 6, 1997.

IV.

The number of shares of the corporation outstanding at the time of such adoption was One Thousand (1,000) shares of Common Stock, all of which were entitled to vote on the foregoing amendment.

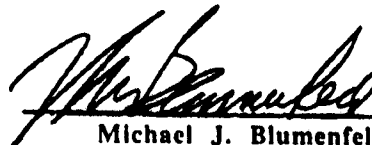
V.

VI.

The amendment will not in any way effect a change in the amount of stated capital of the corporation.
