ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION
OF
COLLEGIATE PACIFIC INC.,
a Texas Corporation

FILED In the Office of the Secretary of State of Texas SEP 23 1998 Corporations Section

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE

The name of the corporation is COLLEGIATE PACIFIC INC.

ARTICLE TWO

Article One of the Amended Articles of Incorporation is hereby amended to read in its entirety as follows:

"The name of the corporation is CHEROKEE DESIGN AND CONSTRUCTION INC. (the "Corporation")."

ARTICLE THREE

The foregoing amendment was adopted by the sole shareholder of the Corporation by written consent effective September 11, 1998.

ARTICLE FOUR

The number of shares of the corporation outstanding at the time of such adoption was one thousand (1,000) shares of Common Stock, all of which were entitled to vote on the foregoing amendment.

ARTICLE FIVE

The number of shares of Common Stock that voted for the amendment was one thousand (1,000); and the number of shares that voted against the amendment was zero (0).

ARTICLE SIX

The amendment will not in any way effect a change in the amount of stated capital of the corporation.
