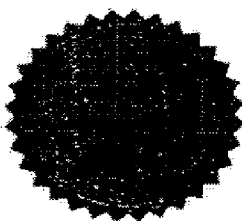

FOURTH: The Certificate of Incorporation of the Surviving Corporation shall be its Certificate of Incorporation.


FIFTH: The merger is to become effective at 12:00:01 a.m., Eastern Standard Time, on December 30, 2002.
