WHEREAS, KNEISSL DACHSTEIN SPORTARTIKEL AKTIENGESELLSCHAFT, an Austrian company, having an address at A4941, MOLLN, 44 AUSTRIA (hereafter referred to as "ASSIGNOR"), is the owner by assignment of all right, title and interest in and to:

a) the trademark WHITE STAR, and U.S. Trademark Registration No. 846,640 therefor in the United States, and in and to the goodwill of the business appertaining to and symbolized by said trademark; and

of which is hereby acknowledged, ASSIGNOR does hereby sell, transfer, convey and assign unto the said ASSIGNEE its successors, legal representatives and assigns, the entire right, title and interest in and to said registrations, together with the trademarks thereof and the goodwill of the business appertaining to and symbolized by said trademarks, and with the right to recover for past infringements thereof.

ASSIGNOR confirms that it owns said trademarks and said registrations, free and clear of any liens, encumbrances, restrictions on transfer, claims, covenants or conditions of any kind, and that it has the full right and power to transfer the trademarks and registrations.

ASSIGNOR hereby authorizes and requests the U.S. Patent and Trademark Office to issue all renewals for said trademarks to ASSIGNEE, its successors, legal representatives and assigns, as assignee thereof, in accordance with the terms of this Assignment.

ASSIGNOR hereby further covenants and agrees that it will communicate to ASSIGNEE its successors, legal representatives and assigns, any facts known to it respecting said trademarks and registrations, and will make all rightful oaths, sign all necessary papers and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to transfer to ASSIGNEE and to obtain and maintain proper trademark protection in the name of ASSIGNEE for said trademarks and registrations.
