WHEREAS, the Assignor wishes to assign, transfer and convey to Assignee all of the Assignor's right in and to the Trademark and the good will associated therewith;




WHEREAS, Assignor wishes to assign; transfer and convey to Assignee all the Assignors right in and to the Mark and Assignee hereby accepts the assignment.
