**ASSIGNMENT OF TRADEMARK COLLATERAL ASSIGNMENT
AND SECURITY AGREEMENT**

This Assignment of Trademark Collateral Assignment and Security Agreement (this "**Assignment**") is made as of March 26, 2005 by CANAM STEEL CORPORATION, a Delaware corporation (the "**Assignor**"), for good and valuable consideration, in favor of CANAM GROUP INC., a Quebec corporation (the "**Assignee**"), pursuant to that certain Purchase Agreement between the Assignor and the Assignee, dated March 26, 2005 regarding the loans made by the Assignor to MARSAN INVESTMENT, LLC, a Delaware Limited Liability Agreement ("**Marsan Investment**").

Marsan Investment entered into that certain Trademark Collateral Assignment and Security Agreement dated September 14, 2004 in favor of Assignor (the "**Security Agreement**").

All capitalized terms used in this Assignment, but not defined in this Assignment, shall have the meaning given to them in the Security Agreement.


Assignor has the power and authority to enter and fully effectuate this Assignment.
